# PRIVACY POLICY ONE-STOP SHOP RESALE RIGHT

### 1. One-stop Shop Resale Right

Article XI.177 of the Belgian Code of economic law states that the resale right shall be exclusively exercised by a one-stop shop, established by the collecting societies managing the resale right.

In this context, SABAM cv and SOFAM cv created the One-stop Shop Resale Right.

### 2. Protection of Privacy

You can freely access the information on the website of the One-stop Shop Resale Right without having to provide any personal details. You only need to provide your personal data to gain access to certain services or to consult specific information.

When you provide personal details, this information will be treated in accordance with applicable legal obligations concerning the processing of personal data and in accordance with the conditions set out below.

## 3. Processing of personal data

When we process your data, both on the website and in an internal database, we use encryption technologies recognized as accepted standards in the IT sector.

The collected personal data cannot be accessed by the public; they can only be accessed by employees or mandataries who are responsible for managing the One-stop Shop Resale Right and need this information to perform their duties.

Personal data are not disclosed to third parties unless you explicitly give us permission to do so or to comply with the legal obligations imposed on the One-stop Shop Resale Right.

### 4. Purpose of processing

When visiting the website of the One-stop Shop Resale Right, following data are processed:

- your personal data upon online submission of a declaration, in your capacity as a player in the professional art market;
- all information regarding the pages you have visited on our website;
- any information you have provided to us voluntarily.

In all these cases, your personal data are processed in the file "customer management".

This information is also used to improve the content of this website and to contact you if necessary regarding information on the One-stop Shop Resale Right.

Your personal data may be used for purposes other than the management of the resale right that are currently not yet provided for in this Privacy Policy. In that case, we will contact you and notify you of the new intended purposes. You will have the opportunity to prohibit the use of your personal information for these new purposes.

#### 5. Right of access, correction and deletion of personal data

You are entitled to access all information registered about you. If you wish to do so, please contact us (in writing, dated and signed request + two-sided copy of your ID card) at the address below.

You also have the right to correct any false or incomplete data about you in our possession or to request that we remove your personal data from one-stop shop's file. If you wish to do so, please contact us (in writing, dated and signed request + two-sided copy of your ID card) at the address below.

### 6. Communication by e-mail, letter or telephone

If you have provided us with your e-mail address, but no longer wish to receive e-mails from the One-stop Shop Resale Right in the future, please inform us of this explicitly at the address mentioned below.

If you provide us with your postal address via the web, you may receive periodic mailings from us containing information on the One-stop Shop Resale Right. If you do not wish to receive such mailings, please inform us of this explicitly at the address mentioned below.

If you provide us with your telephone number via the web, you may be contacted by us by telephone concerning information on the One-stop Shop Resale Right. If you do not wish to receive such calls, please contact us at the address mentioned below.

#### 7. Cookies

The website of the One-stop Shop Resale Right uses cookies. A cookie is a small text file that is stored on your computer or mobile device when you visit a website.

The website of the One-stop Shop Resale Right uses:

- "authentication cookies" in order to identity the user when he is logged on, for the duration of the session;
- "user-centric security cookies" in order to ascertain identification abuses, for the duration of the session.

These cookies are necessary for the proper functioning of the website of the One-stop Shop Resale Right. The information they contain is not shared with third parties, nor will they be used for purposes other than those described above.

You can always delete all cookies from your computer and you can set your browser in such a way that cookies are blocked. More information on this can be found in the instructions or by using the 'help' function of your browser.
